- To promote anti-bullying school policies and Social and Emotional Learning approaches of curriculum.

Expected results:

The participants will learn about:

- The educational policies aimed at violence reduction and social and emotional learning approach at the national levels of partners and local initiatives;
- Good practices at European/ National level focused on violence reduction and social and emotional learning;
- The importance of schools self –reviewing of bullying and other violent behaviours;

- Effective whole school policies and strategies for creating a non-violent learning environment and addressing the causes of bullying and other forms of violence.

Activity programme:

Participants:

- Will participate in presentations and debates on topics related to violence reduction in schools;
- **Will attend workshops on specific topics;**
- Will visit schools and other institutions which are involved in projects focused on bullying reduction
- Will meet officials from education, teachers, pupils, local and county representatives, active in education.

Cost:

Event fee: The event fee will be covered by the hosting agency and it will include accommodation and meals during the activity.

Travel costs: SEPIE will contribute to the travel costs based on the table provided for TCAs. This financial support will be paid directly to the selected participant by SEPIE in compliance with the procedures established by this agency (see information on the SEPIE website).
