#### How can I study in Spain?

If you would like to study in Spain you can apply for your admission at the University of your preference.

The requirements and access regulations vary on every level (Undergraduate, Master and Doctorate degrees). Information on the Spanish University System is available on the Education website to help you prepare your admission.

Spanish universities have International Relations offices to help you with all kinds of questions related to your admission, accommodation, etc.

#### What are the necessary procedures?

If you have been admitted to a course of up to three months you do not have to complete any procedures. You just have to hold a valid identity card or passport.

If you have been admitted for a more than three months-course, you should ask for your registration in the Central Register of Foreign Nationals within three months from the date of your arrival.

### Where do I need to go for the registration procedure?

At the office forforeigners or police station in your place of residence.

# What requirements are necessary for the registration procedure?

- To be enrolled at a private or public education establishment in Spain.
- To have comprehensive health insurance cover valid in Spain.

#### What documents do I need to provide with my application?

In order to register, you need to provide:

- ID or passport.
- Admission letter from a Higher Education Institution in Spain.
- A responsible statement expressing you have enough economic means to live in Spain during your study programme.

### What documents do I need to provide with my application?

In order to register, you need to provide:

- Admission letter from a Higher Education Institution in Spain.
- Health insurance documents. Applicants must take out public or health private insurance with comprehensive insurance cover in Spain.
- A declaration that you have sufficient resources.

## If I am taking part in a European programme to promote educational exchange, do I have to go for the registration procedure?

You have to register as long as you have been selected for a more than 3-month course. Evidence of taking part in this kind of programmes exempts you to provide health insurance documents and declaration of responsible statement.

#### What kind of documents will I receive after the registration process?

Once you apply for the registration, you will get a registration certificate. It is issued immediately, stating your name, nationality, address and number of identity (known as Número de Identidad de Extranjero or NIE. It is useful for your daily activities such as opening a bank account) and the date of the registration.

As part of your residence in Spain, you must comply with the above requirements for the duration of your stay in Spain.

## What documents do I need to present if non-EU family members accompany me to Spain?

- A valid passport.
- A document attesting the family tie.
- The registration certificate of the student he/she is accompanying or joining.
- The application form available at http://extranjeros.empleo.gob.es/
- Three recent photographs passport size.

#### Do I have access to the labour market?

Yes, you and your family members of working age can work in Spain.
